**SECTION 4 - FIRST AID MEASURES**

<b>Eye:</b>	Thorough rinsing for 15-20 minutes of the affected eye with water is recommended. If discomfort or irritation persists, contact a physician.
<b>Skin:</b>	Concentrate and diluted solution is readily removed with water. Abraded or broken skin should be washed carefully and thoroughly. Discontinue use of product. Apply cold compresses to affected areas to relieve any discomfort. If discomfort persists, contact a physician.

<b>Ingestion:</b>	Accidental ingestion of product may necessitate medical attention. In case of accidental ingestion dilute with fluids (water or milk) and treat symptomatically. Do not induce vomiting.

<b>Minor Spill:</b>	Clean up all spills immediately. Slippery when spilt. Wipe up. Place in clean drum then flush area with water.
<b>Major Spill:</b>	Slippery when spilt. Minor hazard. Clear area of personnel. Control personal contact by using appropriate personal protective equipment as required. Prevent spillage from entering drains or water ways. Contain spill with sand, earth or vermiculite. Collect recoverable product into labelled containers for recycling or disposal. Absorb remaining product with sand, earth or vermiculite and place in appropriate containers for disposal. Wash area and prevent runoff into drains or waterways. If contamination of drains or waterways occurs, advise emergency services.

<b>Precautions for Safe Handling:</b>	Limit all unnecessary personal contact. Wear appropriate protective clothing when risk of exposure occurs. Use in a well-ventilated area. When handling DO NOT eat, drink or smoke. Always wash hands with soap and water after handling. Avoid physical damage to containers. Use good occupational work practice.
<b>Conditions for Safe Storage:</b>	No unusual handling or storage requirements. Storage in large quantities (as in warehouses) should be in a well-ventilated, cool area.
